About the Call for Tenders

EFA is seeking to engage in a long-term partnership for Audit, Tax and Consulting Services to support the organization's operational activities.

This call is also regulated under Article II.9 of the Funding Agreement between political parties and foundations and the European Parliament.

3. Audit and Consulting

In addition to ABSL/VWZ registration, EFA is a European political party recognized and funded by the European Parliament. BE GAAP audit is being conducted annually by an external audit firm contracted by the European Parliament. And in 2018, in addition to BE GAAP audit, IFRS audit was required and started. Both audits are conducted by the external auditing firm. Hence, the role of the contractor/supplier is to assist EFA during these annual audits.

EFA undergoes yearly internal financial closure and verification to prepare its books for BE GAAP and IFRS audits and subsequently controlled for compliance with Regulation 1141/2014 of the European Union. This is activity is usually conducted every January.

The BE GAAP audit is usually scheduled on the 1Q of the following year. External auditors conduct an approximately 4-day on-site audit at the EFA office in Brussels. The contractor/supplier is requested to assist on-site for at least 1 day.

The IFRS audit is usually conducted off-site and is currently performed after the BE

GAAP audit.
